# THANK YOU, JERRY

Jerry Gosselin, who has served as our Executive Director for over 10 years, will be leaving the helm at the end of December. During his tenure, he has overseen both the day-to-day business of the Association as well as a number of significant improvements to our programs and properties. His multifaceted roles ranged from worship leader to construction manager; from counselor to advocate; and from business manager to event manager. He has led the organization through good times and challenging times. For all of this, we thank him.

Some highlights (not all of which he would have chosen) include overseeing the construction of the bandstand in Furber Park as well as overseeing the reconstruction of Porter Hall after a freak storm sent a tree through the roof. Jerry has been a strong worship leader and his work with the R&C Committee brought in a wide range of preachers over the years, topped by the visit of an Episcopal Bishop which brought hundreds to a worship service at the Temple. Jerry's adaptability and creative leadership during the COVID epidemic led to developing our online capabilities and securing two significant Federal PPP grants that let us keep all employees and maintain a responsible budget.

Much of the work of the Executive Director that can easily go unnoticed is the day-to-day management of our staff (which quadruples during the summer months): supporting the Board and Committees in their work; ensuring that financial matters are properly handled; seeing that the buildings and properties are appropriately maintained; and, in general, making things happen when they should happen.

We thank you, Jerry, for all that you have done for and on behalf of the Ocean Park Association. We wish you well.

# **WONDERFUL STEP BACK IN TIME,** by Frank Gwalthney

Thanks to some effort by Warren Kenniston, OPA's Director of Facilities, I had the chance to meet some descendants of Agnes L. Park for whom the Rec Hall is named. On September 15 (yes, The Ides of September), Warren and I met four wonderful people who had deep roots in Ocean Park. They were Charles (Chad) Park Henderson – Agnes Park's great grandson from Denver CO, Priscilla Adam West – Agnes Park's great granddaughter from New London NH, Charles (Park) Hutchinson Park Adams – Agnes Park's great grandson from New London NH, and Phoebe Adams – wife of Agnes Park's grandson (C H Park Adams and mother of Priscilla and Park. We met at Jakeman Hall and then walked to the Agnes L. Park Recreation Building for a tour and then we walked up to The Temple for another tour and brief history of Ocean Park.

They were impressed as to how well preserved the Rec Hall was and that it is still a vital, active part of the Ocean Park experience. They took many pictures. On our walk up to The Temple, Phoebe shared her experiences and remembrances of coming to Ocean Park in the 30s, 40s, and early 50s. Her impression was that Ocean Park had not changed much. It still had that quaint, homey feel about it. Their family cottage was at 15 Winona.

As always, The Temple impressed them too. They felt as if they had taken a step back in time and cherished the feeling. They appreciated the brief history of The Free Will Baptists; especially Oren B. Cheney, who was one of the founders of Bates College, Ocean Park (the first president), and his active national leadership in the abolition movement from the 1850s until his death. They shared with me that family legend has it that Agnes Park died while attending one of the Sunday Worship Services in the summer of 1951.

We finished the mini-tour by me handing off the group to Charlie and Ruth Gladu who gave them a tour of the Historical Room and information about Agnes L. Park and the Rec Hall. They were impressed with how much information was available to the public so that they could learn more about their beloved ancestor, Agnes L. Park.
